On Thursdays at lunch Craig and Todd witness at the Galleria Mall. Please pray for open conversations and receptive hearts to talk to and share the Gospel with.

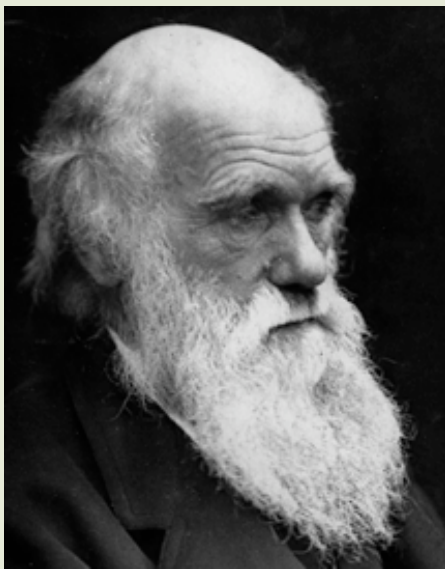
Saturday, August 9, OzzFest at Pizza Hut Park in Frisco

Bring It On!

"Go therefore, and teach all nations, baptizing them in the name of the Father and the Son, and the Holy Spirit..." Matthew 28:19

Todd and I were witnessing at The Shops at Legacy on Sunday afternoon. I spoke with two teenagers. She identified herself as Agnostic. He said he was an atheist. So starting out, I first showed him that he can not be an atheist because he can not possess all of the knowledge in the world which is what it would take to know for sure that God does not exist. They told me that since we can't see God, he does not exist. I showed them His creation and then we talked about the Bible. She made a bold statement that there is no science to back up the Bible. So I reached in my pocket and pulled out an assortment of tracts that I had with me. One of them is a booklet that we like to hand out titled "Scientific Facts in the Bible". This booklet explains how the Bible has had science right for thousands of years while scientists keep changing their mind and come up with new theories every few hundred years until them eventually come to agree with what the Bible says. We then moved on to the hypothetical court room of judgement before God. I say hypothetical because since these two do not believe in God we can only ask them "what if" you face judgement even though the Bible says that judgement is a certainty. So I ran

through a few of the Ten Commandments with them. I did get them to admit to breaking several of them. But when I asked if they would be guilty before God they went back to the argument that God does not exist. So I asked them "what if you are wrong?" To which she interjected, "what if you are

wrong?" I then explained that if they are right and I am wrong that there is no god and we are all in the same boat. That seemed to please her. However, I went on to explain to her that if I am right and she is wrong, then there is a God and that God will judge everyone when they die. I then told her what Jesus tells us in Luke 13, "Unless you repent, you too shall perish." I explained that on that day she would be subject to the wrath of God for all of eternity. Her response was, "Bring it On." I'd hate to be in here shoes then. Please be praying that she sees the light.

As I witnessed to another man this week and presented the ten commandments he got very uncomfortable with being confronted with his sin. He said he did not want to talk about it anymore. I asked him when would be a better time. He said he was not sure. I reached in my pocket and took out one of my business cards. I handed it to him and asked him to call me on the day he is going to die so we could discuss it before it is too late! Judgement is real whether people believe it or not. We must warn people of the judgement to come.
